D. Public Comments – Mely Martinez with Karnes City Chamber of Commerce thanked the City of Karnes City for sponsoring the Senior Citizen Bingo this month.

E. Consent Agenda:

- (1) Minutes
 - a. Discuss and consider approving the minutes from; March 22, 2022
- (2) Discuss and consider monthly reports from City Departments.

M&S engineering presented the monthly update. After discussion, a motion was made by Councilmember Ebrom and seconded by Councilmember Rosales to approve the Consent Agenda. The vote was 5-0 in favor and the motion was declared unanimously passed.

F. UNFINISHED BUSINESS (CONSIDER AND ACT UPON):

- (4) Discuss and consider the update on the City's purchase of a 6.64-acre property located at 1007 N. Highway 123, Karnes City, Texas - Mayor Skloss presented the update from CS Butler. No action taken.

G. NEW BUSINESS (CONSIDER AND ACT UPON):

- (5) Discuss and consider construction bids received and take possible action on awarding of a construction contract for the repairs to the bridge on CR 246 off S. Browne, Karnes City, Texas Russell Jaskinia presented the Council with the bid tabulation and gave his recommendation. Highway 123, Karnes City, Texas Mayor Skloss informed the Council that he requested this item to be on the agenda, he would like to Council to be informed with the move and give any input. Councilmember Lyssy expressed her concern to have the PD so far from downtown. CM Roberts stated we should all move and we can decide if any changes need to be made when there. After further discussion, a motion was made by Councilmember Ebrom and seconded by Councilmember Loya to move forward with the relocation of all city offices. The vote was 5-0 in favor and the motion was declared unanimously passed.
