On this 28th day of March 2023, the City Council of the City of Karnes City, Texas convened in a Regular Monthly Meeting at 6:00 P.M. in the City Hall with the following members answering to "Roll Call":

- E. Consent Agenda:
- (1) Minutes
 - a. Discuss and consider approving the minutes from; February 28, 2023
- (2) Discuss and consider monthly reports from City Departments.

After discussion, a motion was made by Councilmember Rosales and seconded by Councilmember Loya to approve the Consent Agenda. The vote was 3-1 in favor and the motion was declared passed, Councilmember Ebrom voted against the motion.

- G. NEW BUSINESS (CONSIDER AND ACT UPON):
- (3) Discuss and take possible action on the Mayoral Proclamation declaring the month of April as "National Sexual Assault Awareness Prevention Month." - Mayor Skloss presented the proclamation. After further discussion, a motion was made by Councilmember Ebrom and seconded by Councilmember Lyssy approve the Mayoral Proclamation declaring the month of April as "National Sexual Assault Awareness Prevention Month." The vote was 4-0 in favor and the motion was declared unanimously passed.

- (4) Discuss and take possible action to authorize the City Council and/or their designees to join the TASB Energy Cooperative through the Interlocal Agreement – Haylee informed the Council of the agreement. Lou Mireles with Buy Board presented the Council with information on TASB Energy Cooperation. After further discussion, a motion was made by Councilmember Ebrom and seconded by Councilmember Rosales to authorize the City Council and/or their designees to join the TASB Energy Cooperative through the Interlocal Agreement. The vote was 4-0 in favor and the motion was declared unanimously passed.
- (5) Discuss and take possible action on repealing Ordinance 2023-004, Declaring Unopposed Candidates for the Offices of City Councilmember District #2 and Councilmember #4 – CM Butler informed the Council that since the Mayor's election is "at large" the unopposed Candidates for districts #2 & #4 will have to remain on the ballots. We will need to repeal the already approved ordinance 2023-004. After further discussion, a motion was made by Councilmember Loya and seconded by Councilmember Lyssy to repeal Ordinance 2023-004 Declaring Unopposed Candidates for the Offices of City Councilmember District #2 and Councilmember #4. The vote was 4-0 in favor and the motion was declared unanimously passed.
- (6) Discuss and take possible action on whether to ratify city's acceptance and to proceed with city's application to AACOG for grants through the Hurricane Harvey CDBG-Disaster Recovery Local Infrastructure Program – City Attorney Jessie Lopez informed the council of the funding. After further discussion, a motion was made by Councilmember Ebrom and seconded by Councilmember Lyssy to accept the funds from AACOG. The vote was 4-0 in favor and the motion was declared unanimously passed.
- (7) Discuss and take possible action awarding an administrative services contract with Langford Community Management for the preparation of the City's 2023 - 2024 Texas Community Development Block Grant Program – CM Butler informed the Council that Langford Community Management was the only one that submitted an RFO for administrative services. After further discussion, a motion was made by Councilmember Loya and seconded by Councilmember Rosales to award the administrative services contract to Langford Community Management for the preparation of the City's 2023 - 2024 Texas Community Development Block Grant Program. The vote was 4-0 in favor and the motion was declared unanimously passed.
- (8) Discuss and take possible action on action concerning award of the engineering services contract with Thonhoff Consulting Engineers, Inc. for the preparation of the City's 2023 - 2024 Texas Community Development Block Grant Program - CM Butler informed the Council that the City received three RFO's for engineering services, after scoring the recommendation would be to award to Thonhoff Consulting Engineers, Inc. After further discussion, a motion was made by Councilmember Ebrom and seconded by Councilmember Lyssy to award the Engineering services contract with Thonhoff Consulting Engineers, Inc. for the preparation of the City's 2023 - 2024 Texas Community Development Block Grant Program. The vote was 4-0 in favor and the motion was declared unanimously passed.

- (9) Discuss and take possible action concerning award of the administrative services contract with Langford Community Management for the preparation of the City's application to the Texas General Land Office, (GLO) CDBG-MIT Grant CM Butler informed the Council that Langford Community Management was the only one that submitted an RFP for administrative services. After further discussion, a motion was made by Councilmember Rosales and seconded by Councilmember Lyssy to award the administrative services contract to Langford Community Management for the preparation of the City's application to the Texas General Land Office, (GLO) CDBG-MIT Grant.
