- (3) Discuss and take possible action to authorize the city's acceptance of a \$15,000 donation from San Antonio River Authority (SARA) -CS Butler informed the Council that SARA is donating \$15,000 for the purchase of emergency call buttons and trash containers. After further discussion a motion was made by Councilmember Hernandez and seconded by Councilmember Dziuk to authorize the city's acceptance of a \$15,000

donation from San Antonio River Authority (SARA). The vote was 5-0 in favor and the motion was declared unanimously passed.

- (4) Discuss and take possible action on Ordinance No. 2023 011 amending Karnes City Code, Article II Parks and Recreation Advisory Board to revise the board's composition, board terms, and meeting dates – Mayor Skloss presented the Ordinance, he also stated this was from the last month's meeting now it just needs approval. - (7) Discuss and take Possible action on the proposal from Texas Air Systems in the amount of \$23,995.00 to replace the city's water-cooling tower fan motor belt tension rod assemblies - Mayor Skloss informed the Council that the maintenance department fixed the issue, no action taken.
- (8) Discuss and take possible action on the indexed price increase stipulated in the Waste Connections contract with the City of Karnes City - CS Butler presented the price increase. After further discussion a motion was made by Councilmember Rosales and seconded by Councilmember Lyssy to approve the indexed price increase stipulated in the Waste Connections contract with the City of Karnes City.
