(2) Discuss and consider monthly reports from City Departments.

After discussion, a motion was made by Councilmember Lyssy and seconded by Councilmember Dziuk to approve the Consent Agenda. The vote was 4-0 in favor and the motion was declared unanimously passed.

The vote was 3-0 in favor and the motion was declared unanimously passed, Councilmember Lyssy abstained from voting.
- (6) Discuss and take possible action on Ordinance 2023-014, adjusting the city's residential and commercial trash collection rates to reflect the annual and automatic price adjustment made by Waste Connections, Inc. and as provided under the terms of company's contract with the City - CS Butler presented the ordinance. - (10) Discuss and take possible action on whether to adjust the date or to cancel the November and December City Council Meeting CS Butler informed the Council that November meeting is the week after thanksgiving, that would move up the deadlines for adding an item to agenda and the posting of the agenda. The December meeting falls on the week of Christmas. After further discussion, a motion was made by Councilmember Dziuk and seconded by Councilmember Hernandez to leave the November meeting as is and cancel the December regular meeting. The vote was 4-0 in favor and the motion was declared unanimously passed.
- (11) Discuss and take possible action on the utility map prepared and submitted by Schneider Engineering CS Butler presented the maps, some changes are needed, no action taken.
- (12) Discuss and take possible action on adopting the city's 2024 Holiday Calendar CS Butler presented the 2024 Holiday Calendar. After further discussion, a motion was made by Councilmember Dziuk and seconded by Councilmember Loya to approve the City's Holiday Calendar. The vote was 4-0 in favor and the motion was declared unanimously passed.
